

## CLUB MEMBERSHIP AGREEMENT

THIS MEMBERSHIP AGREEMENT (hereinafter referred to as the "Agreement") is made and entered into on this {day} day of {month}, {year} at Dharamshala, Himachal Pradesh.

BY AND BETWEEN

**STELLA & NOTTE SOCIAL CLUB PRIVATE LIMITED**, a company incorporated under the provisions of the Companies Act, 2013, having its registered office at {\*\*\*\*}, India (hereinafter referred to as the "Club" or "SNC", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors-in-interest and permitted assigns) of the FIRST PART;

AND

2. {name\_of\_member}, Son/Daughter/Wife of {father\_or\_husband\_name}, aged about {age} years, residing at {full\_address\_of\_member}, holding Aadhar No. {aadhaar\_number} (hereinafter referred to as the "Associate Member", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include his/her legal heirs, executors, administrators and permitted assigns) of the SECOND PART.

Prime Member & Associate Member together shall be hereinafter jointly/singly referred as "Member". Further the Club and the Member shall hereinafter be collectively referred to as the "Parties" and individually as a "Party".

### WHEREAS:

- A. The Club is a private social and recreational club, operating under the name and style of "Stella & Notte Social Club", created exclusively for couples who seek meaningful connections and engaging conversations, fostering a curated circle of like-minded individuals.
- B. The Member is desirous of obtaining membership of the Club and has represented that he/she is of good standing, meets the Club's profile criteria and is willing to abide by all the rules, regulations, policies, bye-laws, Terms of Use, Privacy Policy, Disclaimer, FAQ Section and Club Rules (Fine Print Section) of the Club as may be in force from time to time.
- C. The Club, relying upon the representations made by the Member, has agreed to grant membership to the Member, which shall also extend to the Member's spouse (hereinafter referred to as the "Associate Member"), subject to the terms and conditions hereinafter appearing.
- D. The Member has read, understood and unconditionally accepts the Club's Terms of Use, Privacy Policy, Disclaimer, FAQ Section and Club Rules (Fine Print Section), which are available on the Club's official website, [www.stellanotte.in](http://www.stellanotte.in) and are annexed hereto as schedules, forming an integral part of this Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND AGREEMENTS CONTAINED HEREIN and FOR OTHER GOOD AND VALUABLE CONSIDERATION, THE RECEIPT AND SUFFICIENCY OF WHICH ARE HEREBY ACKNOWLEDGED, THE PARTIES HERETO AGREE AS FOLLOWS:

### ● GRANT OF MEMBERSHIP

- 1.1. The Club hereby grants to the Member and the Member hereby accepts, an exclusive, invitation-only membership of the Stella & Notte Social Club, effective from the date of execution of this Agreement ("Effective Date"), subject to the timely payment of the fees as per the Club updated terms & condition of enrollment.
- 1.2. The membership granted herein is strictly a Couple Membership, admitting two individuals: The Member (as the Primary Member) and the Spouse (as the Associate Member). Both the Member and the Spouse shall be entitled to enjoy the rights, privileges and benefits of the Club, subject to the terms of this Agreement. No solo entries are permitted for membership or participation in events, except as explicitly allowed for guests under Clause 4.6.
- 1.3. The membership is personal to the approved couple (Member and Spouse) and is strictly non-transferable, non-assignable and non-heritable.

### ● FEES AND PAYMENT OBLIGATIONS

- 2.1. Enrollment and Membership Fees: For the Financial Year 2026-27, the Member shall pay the following non-refundable fees at the time of signing this Agreement: a. One-time Club Membership Fee which includes the Annual Maintenance Charge for the first year. The membership shall be activated only upon the realisation of the said fees by the Club and upon signing of this Membership Agreement.
- 2.2. Annual Maintenance Charges (AMC): From the second year onwards, to continue the membership, the Member shall be liable to pay an Annual Maintenance Charge (AMC) as decided by the Club and modified time to time on or before the completion of the 12 (Twelve) month period from the date of payment of Club Membership. The AMC is subject to revision at the sole discretion of the Club.
- 2.3. Consequence of Non-Payment of AMC: If the AMC is not paid from the second year onwards, the membership will be considered inactive. If the Member wishes to reactivate the membership after a period of non-payment, the Member shall be required to pay the full AMC for the missed year(s) and the current year. The renewal clock shall start from where the last membership actually ended, not from the date of re-payment. There shall be no proportionate billing or half-season passes. Failure to pay the AMC within a grace period of thirty (30) days from the due date may result in the automatic termination of membership and the Member's name being struck off from the Register of Members. Such a Member shall forfeit all rights and privileges and may be required to undergo the entire application process afresh, including the payment of prevailing Enrollment and Membership Fees, for re-admission.

2.4. Monthly Event Fees: The Club shall organize various gatherings, meet-ups or events ("Monthly Events" or "Events"). The Club shall notify the fee for each Event ("Event Fee") to all members in advance. The Member shall be liable to pay the Event Fee for each Event they attend, which is in addition to the Membership Fee and the AMC. The membership fee is an entry ticket to the club, while event fees fuel the experience.

2.5. Payment Method: All payments to the Club shall be made through digital modes only. The Club does not accept cash payments.

2.6. No Instalments: All fees, including Membership Fee, AMC and event fee, are required to be paid upfront and in full. The Club does not offer instalment payment options.

2.7. Non-Refundability: All fees paid to the Club, including the Membership Fee, AMC and Event Fees, are strictly non-refundable under any circumstances whatsoever.

- ATTENDANCE AND PENALTY FOR NON-ATTENDANCE

3.1. Attendance at all Monthly Events is compulsory for both the Member and the Spouse. This mandatory attendance is crucial to foster a strong community, maintain the decorum and uphold the spirit of the Club, ensuring synergy and active participation.

3.2. In the event that the Member and/or the Spouse are genuinely unable to attend any Monthly Event, the Member shall be liable to contribute a sum of INR 1,000/- (Rupees One Thousand only) towards a social cause as a penalty for non-attendance ("Non-Attendance Penalty").

3.3. The said Non-Attendance Penalty shall be paid by the Member directly to a Non-Governmental Organisation (NGO) designated by the Club. The Member shall furnish proof of such payment to the Club within seven (7) days from the date of the missed event. It is expressly clarified that the Club shall not retain any portion of the Non-Attendance Penalty and the same is a direct contribution towards a trusted NGO, ensuring that even if the Member misses the event, their kindness contributes to a purpose.

3.4. Repeated failure to attend Monthly Events, even with the payment of the Non-Attendance Penalty, may be construed as a lack of engagement with the Club's activities and may be a ground for review or termination of membership at the discretion of the Club's management, as active participation is a core value.

- RULES, REGULATIONS and POLICIES

4.1. Adherence to Club Policies: The Member and the Spouse hereby agree to be bound by and strictly adhere to all rules, regulations, by-laws, policies and the code of conduct of the Club, as may be framed, amended or modified by the Club from time to time. This includes, but is not limited to, the Club's Terms of Use, Privacy Policy, Disclaimer, the FAQ Section and the Club Rules (Fine Print Section) as published on the Club's official website, [www.stellanotte.in](http://www.stellanotte.in), which the Member acknowledges having read, understood and unconditionally accepted. These documents are annexed hereto as Schedule-A (Terms of Use), Schedule-B (Privacy Policy), Schedule-C (Disclaimer), Schedule-D (FAQ Section), forming an integral part of this Agreement.

4.2. Amendments to Policies: The Club reserves the absolute right to amend, modify or change its rules, regulations and policies, including the fee structure, at its sole discretion. Such changes shall be notified to the members by posting them on the Club's official website ([www.stellanotte.in](http://www.stellanotte.in)) or through other modes of communication and shall be binding on all members from the date of such notification.

4.3. Club Ethos and Values: The Member and Spouse agree to uphold the core values of the Club, which include:

a. No Labels, Just Good People: The Club is a neutral zone, welcoming individuals of all beliefs, backgrounds and identities, focusing on good vibes and genuine connections rather than religion, nationality, caste or gender.

b. Rolling Solos: Membership and participation are strictly for couples only; no single entries are permitted.

c. Invitation-Only Access: Membership is exclusive and by invitation only, following a rigorous application and review process by the Executive Committee to ensure a match in vibe and frequency.

d. Your Vibe = Your Ticket In: The Club seeks educated, working, mature couples who bring good energy, positive attitudes, easy conversations and a social spark. Personality and synergy are paramount, transcending professional titles or status.

e. No Politics, Just Vibes: The Club is a neutral zone, free from political affiliations, debates, party promotions or hidden agendas. Members are expected to leave political discussions and aspirations outside the Club premises and events.

4.4. Dress Code: Members and their guests are required to adhere to a smart casual, classy dress code, suited to the occasion. Flip-flops, gym wear, lazy outfits or anything deemed inappropriate for a social club setting are strictly prohibited.

4.5. Social Media & Privacy: Members must respect the privacy of other members. No unauthorized photos, videos or social media tagging of other members or Club events without explicit prior consent. The Club maintains a strict privacy policy to protect its members and proprietary information.

4.6. Guest Policy: Members may bring a guest couple (a "plus-two") to an event, provided prior notification is given to the Club. The hosting Member couple shall cover the event fee for their guests. A guest couple is granted a one-time pass to experience the Club's vibe. Subsequent attendance by the same guest couple will require them to apply for full membership.

4.7. Children at Events: The Club primarily focuses on creating an ecosystem for couples. While the Club adores children, most events are exclusively for members. The Club may, however, explore hosting one event every six months where children under 10 can be part of the experience, to maintain a balance.

4.8. Event Format: The Club does not adhere to a fixed event format but curate diverse experiences, including brunches, dinners, parties, festive celebrations, games, outdoor getaways, live music, stand-up comedy and mini-retreats, based on the collective preferences and inputs of its members.

4.9. Club Alliances: The Club actively partners with premium cafés, pubs, restaurants and experience creators to unlock exclusive deals and perks for its members. Details of such alliances and offers will be communicated to members periodically.

- CONDUCT AND DISCIPLINE

5.1. The Member and the Spouse shall at all times maintain decorum, exhibit mutual respect and conduct themselves in a manner befitting the reputation and standards of the Club. Any act of misconduct, misbehavior, nuisance, harassment or non-compliance with the Club's policies by the Member or the Spouse shall be deemed a material breach of this Agreement.

5.2. The Member shall be vicariously liable for the conduct of the Spouse and any guests accompanying them to the Club premises or events. Any breach committed by the Spouse or guests shall be treated as a breach committed by the Member.

5.3. Zero-Tolerance Policy: The Club maintains a zero-tolerance policy for any form of misconduct, shady behaviour or violation of its rules. Members are expected to treat each other with kindness and respect. Any instance of crossing the line will result in immediate and irreversible revocation of membership, with no second chances.

- **TERMINATION OF MEMBERSHIP**

6.1. The Club reserves the absolute right to suspend or terminate the membership of the Member with immediate effect, without any prior notice, upon the occurrence of any of the following events: a. Any default in the payment of AMC, Event Fees or any other dues to the Club. b. Any act of misconduct, misbehavior, indiscipline or harassment by the Member or the Spouse or any guest accompanying them. c. Any material breach of the terms and conditions of this Agreement, the Club's Terms of Use, Privacy Policy, Disclaimer, FAQ Section or Club Rules (Fine Print Section). d. If the Member is convicted of any offence involving moral turpitude. e. If the Member acts in a manner that is prejudicial to the interests, reputation or harmonious environment of the Club. f. Violation of the Club's zero-tolerance policy.

6.2. In the event of termination of membership by the Club under this clause, the Member shall not be entitled to any refund of the Membership Fee, AMC or any other fees paid to the Club, all of which shall stand forfeited.

6.3. The Member may voluntarily terminate the membership by providing thirty (30) days' prior written notice to the Club. In such a case, no refund of any fees paid shall be made, as all fees are non-refundable.

- **REPRESENTATIONS AND WARRANTIES**

7.1. The Member represents and warrants that all information provided in the membership application form and otherwise to the Club is true, complete and accurate in all respects.

7.2. The Member represents and warrants that he/she is of legal age, sound mind and has the financial capacity to meet the obligations under this Agreement.

7.3. The Member further represents and warrants that he/she, along with the Spouse, meets the profile criteria of the Club, being an educated, working, mature couple who brings good energy and a positive attitude and understands that membership is based on a match of "vibe" and "personality."

- **CONFIDENTIALITY:**

8.1. The Member and Spouse acknowledge that during the course of their membership, they may come into possession of confidential information pertaining to the Club, its operations, other members or events. The Member and Spouse agree to keep all such information strictly confidential and not to disclose, disseminate or use it for any purpose other than for the enjoyment of Club privileges, without the prior written consent of the Club. This includes respecting the privacy of other members and refraining from unauthorized sharing of personal details or images.

- **INTELLECTUAL PROPERTY**

9.1. All intellectual property rights, including but not limited to copyrights, trademarks and proprietary information, in relation to the Club's name, logo, website content, event materials and any other content created or used by the Club, shall remain the sole and exclusive property of the Club. The Member and Spouse shall not use, reproduce or exploit any such intellectual property without the prior written consent of the Club.

- **INDEMNITY AND LIMITATION OF LIABILITY**

10.1. The Member agrees to indemnify and keep the Club, its directors, officers, employees and agents harmless from and against any and all claims, losses, damages, liabilities, costs and expenses (including legal fees) arising out of or in connection with any breach of this Agreement by the Member or the Spouse or any act of negligence, misconduct or violation of Club policies on their part.

10.2. The Club shall not be liable for any loss or damage to the personal property of the Member or the Spouse or for any injury sustained by them during any Club event. The maximum liability of the Club, if any, shall not exceed the amount of the AMC paid by the Member for the relevant year.

- **GOVERNING LAW AND DISPUTE RESOLUTION**

11.1. This Agreement shall be governed by and construed in accordance with the laws of India.

11.2. Subject to the provisions of Clause 11.3, the Courts in Dharamshala, Himachal Pradesh, shall have exclusive jurisdiction to entertain any suit or proceeding arising out of this Agreement.

11.3. Any dispute or difference arising out of or in connection with this Agreement shall be first resolved through amicable settlement by the Parties.

- **MISCELLANEOUS**

12.1. Notices: Any notice required to be given hereunder shall be in writing and sent to the addresses of the Parties mentioned above or to the registered email addresses of the Parties.

12.2. No Partnership or Agency: Nothing in this Agreement shall be construed as creating a partnership, joint venture, agency or employment relationship between the Parties. The Member is an independent member of the Club.

12.3. Waiver: No waiver of any provision of this Agreement shall be effective unless it is in writing and signed by the Party granting the waiver. A waiver of any breach shall not be deemed a waiver of any subsequent breach.

12.4. Assignment: The Member shall not assign or transfer any of his/her rights or obligations under this Agreement without the prior written consent of the Club. The Club may assign its rights and obligations under this Agreement to any of its affiliates or successors.

12.5. Entire Agreement: This Agreement, along with its Schedules, constitutes the entire agreement between the Parties and supersedes all prior oral or written agreements, understandings or arrangements.

12.6. Amendment: This Agreement may only be amended or modified by a written instrument executed by both Parties.

12.7. Survival of Clauses: Clauses pertaining to Fees and Payment Obligations (to the extent of outstanding dues), Confidentiality, Intellectual Property, Indemnity and Limitation of Liability, Governing Law and Dispute Resolution and Miscellaneous shall survive the termination or expiration of this Agreement.

12.8. Force Majeure: The Club shall not be liable for any failure or delay in performance of its obligations if such failure or delay is caused by a Force Majeure event, including but not limited to acts of God, war, pandemic, government restrictions or any other event beyond the reasonable control of the Club.

12.9. Severability: If any provision of this Agreement is held to be invalid or unenforceable, the validity and enforceability of the remaining provisions shall not be affected.
